According to the National Agricultural Statistics Service in New Jersey, there were 3 days suitable for fieldwork for the week ending Sunday; April 26th, 2020. Topsoil moisture supplies were 60 percent adequate, and 40 percent surplus. Subsoil moisture supplies were 65 percent adequate, and 35 percent surplus. Pasture conditions ranged from 5 percent fair, and 95 percent good.
